jobs in the Tech 300 program.

Mrs. Stewart backed the threats up by using the names of professional people in the community, Mrs. Miller said.

"Mrs. Stewart told me, 'You stop riding my daughter's back or you'll be sorry. I'll have you out of your job and out of teaching,' "Mrs. Miller's statement read.

Mrs. Stewart, one of seven commissioners elected May 6, will take her seat on the school board in 1982. Board members' terms are staggered.
