Matthew Allen, 29, of 2936 Cavanaugh road an Oldsmobile employe, suffered grave burns about 2:40 a.m. when a gasoline stove exploded at his home. He was removed to Edward W. Sparrow hospital where his condition was reported "fair" at noon Tuesday. He suffered first and second degree burns about the hands and legs.

Mr. Allen died 23 July 1944 and was interred Evergreen Cemetery, Lansing, Ingham County.

2-Car Crash

Two Boys Quizzed About Alleged Theft of Auto **Involved** in Collision

Eight persons were injured in a head-on collision on Cavanaugh rd. east of Hagadorn rd. Two youths in one car were being questioned by police concerning an alleged theft of one of the vehicles.

State police said a car, which had been reported stolen, driven by David Dee, 14, of 3078 Lake Lansing rd., pulled out of a private driveway and collided head-on with another car driven by Frank J. Backes, 54, of R. 4, Ma-

Mr. Backes sustained cuts on chin and left knee, and possible bone fractures. His wife, Kay, 52, received fractured ribs, cuts and bruises.

Dee sustained a broken right shoulder and cuts and bruises, and LeRoy Bouch, 14, of 1687 Lake Lansing rd., received scalp cuts.

Other persons in the car driven by Dee included: Duane Roberts,

by Dee included: Duane Roberts, 15, of R. 2, Okemos, who suffered a skull injury; Lawrence Bouch, 6, brother of LeRoy, sustained a ut forehead; Shelby Greer, 16, of 940 Cavanaugh rd., cuts and inuries to arms and nose, and Sharene Allen, 14, of 2946 Cavanaugh d., suffered an injured back and ruised right, eve. ruised right eye.

The injured were removed to Ed-

ward W. Sparrow hospital.

Dee and the two Bouch boys
were released after treatment. The others remained in the hospital where their conditions were re-ported "fairly good" Thursday.

According to authorities the car Dee was driving was reported stol-en from the 1000 block of E. Grand River ave., about 6:30 p. m. Wednesday. LeRoy Bouch and David Dee were being questioned by Lansing police detectives concern-ing the stolen car which belonged to Lawrence Hodges of 121½ E. Grand River ave.
Officers said that the other pas-

sengers in the vehicle did not know the car was stolen. Police said both vehicles involved in the crash were nearly demolished.
