

OKEMOS, Nov. 15 — Mrs. M. Brand, one of the two speech correctionists employed by the Ingham county board of education, gave a discussion of the speech defect problems among school children, at the Okemos P. T. A. meeting Tuesday evening.

She stated that 10 percent of the children have some speech difficulties, half of which are simple and readily corrected. She demonstrated the "s" difficulty and correction methods with one of the classes. 


"My parents and sister Nancy have passed away. I still have both brothers here in Michigan."
